## **General requirements:**

The conditions meet the requirements of the EN 1090-2 standard in the relevant execution class EXC 2, 3

- 1. The certificate of conformity must be used only for the purposes for which it was issued.
- 2. The certified product must be permanently in accordance with the technical specification.
- 3. In accordance with ČSN EN ISO/IEC 17065, the holder of the certificate is obliged to:
  - a) inform the certification body about all changes, i.e. product or production process modification, material changes, changes to the production management system, which affect the conformity of the certified product;
  - b) notify the certification body of changes in ownership, structure or management;
  - c) keep records of all complaints regarding non-compliance of the certified product with the requirements of the relevant standard;
  - d) take appropriate measures to eliminate the discrepancy and document the measures taken;
- e) submit the above-mentioned records of complaints to the certification body upon request;
- f) enable the certification body to carry out periodic supervision during the period of validity of the certificate.
- 4. The certification body carries out a repeated evaluation of the product in the event that there are changes affecting the properties of the product, a change in technical specifications or significant changes in the ownership, structure or management of the organization.
- 5. The certification body announces changes to certification requirements.
- 6. The validity of this certificate is subject to a positive evaluation of the results of the inspections contained in the reports of the certification body and handed over to the certificate holder.
- 7. The applicant has the right to appeal against this certificate to COV 3170/TÜV NORD Czech s.r.o. within 15 days from the date of delivery of this certificate.

#### Certificate revocation

In order to cancel the validity of the certificate, the company must confirm the cancellation in writing to the certification body.

If a valid certificate should be extended, it is necessary to apply to the certification authority for an extension at least **2 months** before the expiration date.
